Section 4. First aid measures

Description of necessary first aid measures

Eye contact

Inhalation

Remove victim to fresh air and keep at rest in a position comfortable for breathing. Do not induce vomiting unless directed to do so by medical personnel. If vomiting occurs, the head should be kept low so that vomit does not enter the lungs.
